



Leadership: **Michael D. Hartline**, Ph.D., dean and Charles A. Bruning Professor of Business Administration, has led the college since April 1, 2016. He is the sixth dean of the college.

Founding and Honorary Chairman: **Dr. Herbert Wertheim** invested \$65 million in 2025 that renamed the college and the college's new building, along with providing landmark resources to strengthen faculty excellence, expand student access and power innovative programs. An optometrist, inventor, businessman and philanthropist, Wertheim is founder and president of Brain Power Incorporated (BPI), the world's largest manufacturer of optical tints.

About the Herbert Wertheim College of Business at Florida State University: The college is redefining how preeminent business education delivers for students, industry and society. Founded in 1950, the college has experienced steady growth – including a 30.5% increase in undergraduate enrollment over the last five years – making it one of the largest business schools nationwide. The college trumpets student success: Nearly every first-year business student – 97% at last count – returns for sophomore year, and 84% graduate in four years.

Location: The college occupies the **Herbert Wertheim Center for Business Excellence** on FSU's main campus in Tallahassee, the state capital of Florida. The largest academic structure on campus, the college's home facility opened for classes in January 2026.

Accreditation: For 63 consecutive years, the college has earned accreditation by the Association to Advance Collegiate Schools of Business (AACSB International), the highest standard for business schools and only achieved by 6% worldwide. The college's Accounting program also secured an additional specialized AACSB accreditation held only by 195 schools.
